- 1.2 The following items are intended to revise and clarify the Contract Documents, and shall be included by the Bidder in their proposal.
- 1.3 Bidders shall verify that their sub-bidders are in full receipt of the information contained herein. Bidders shall acknowledge receipt of each addendum on their Bid Form.

#### 2.0 **CLARIFICATIONS**

## 3.0 QUESTIONS

- 3.1 Q: The Owner will pay for permits, correct?
  - A: Per pre-bid meeting minutes previously issued, the Owner will pay for general contract permit fees. GC / subs are responsible for all other permit fees.
- 3.2 Q: Is the GC required to remove floor coverings? Who would be responsible for removing the current flooring if it is deemed to be asbestos-containing?
  - A: The GC is responsible for removing existing floor coverings. However, as indicated in the pre-bid meeting minutes, "If hazardous materials are suspected or encountered, Contractor is to stop work, leave the area, and notify the Owner for abatement."
- 3.3 Q: Please be aware now that the school is picking up all of the builder's risk that if circumstances are out of our control that we cannot be responsible for that additional premium for insurance as we have no control over the factories.
  - A: As indicated in Addendum 4: "The Owner will provide Builder's Risk insurance as required."
- 3.4 Q: Are there specific additional insurance requirements for the work to be performed on second shift, if that alternate is chosen?
  - A: There are no additional insurance requirements related to the time of day at which work is performed.
- 3.5 Q: Regarding the 2 transaction windows, what type of glazing is required?
  - A: Provide glazing as indicated on drawings.
