1.0 GENERAL NOTES:

1.1 Bidders are hereby notified that this Addendum shall be and hereby becomes part of their Contract Documents, and shall be attached to the Project Manual for this project.

- 1.2 The following items are intended to revise and clarify the Drawings and Project Manual, and shall be included by the Bidder in their proposal.
- 1.3 Bidders shall verify that their Sub-bidders are in full receipt of the information contained herein.
- 1.4 All addenda will be sent out to the registered and invited plan holders only via email. Contractors are encouraged to keep an eye on their email accounts during the bidding period for such updates.

2.0 <u>PREBID MEETING</u>:

- 2.1 A Prebid Meeting was held on Tuesday, September 26, 2023, at 1:00 p.m. on site. The following items were reviewed:
 - A. Project Description: A brief overview of the Project was discussed. An overall review of the construction drawings was presented. The Bid Advertisement e-mail was also reviewed.

- B. Owner's Representative: Patrick McKenna, OMB/DFM Construction Project Manager
- C. Project Schedule: The work needs to be completed asap. The purchase order will be expedited to the contractor after bidding and when all contractual documents have been submitted.
- D. Bid schedule is as follows:
 - 1. The bids are due by **Tuesday**, **October 17**, **2023 before 4:00 p.m. at the Haslet Armory front desk (REVISED Date)**.
 - Substitution requests will be received until 4:00 p.m. on Monday, October 9, 2023. (REVISED Date). Instructions for requesting substitutions are very specific and are contained in the project manual. If the contractor does not follow the processes it is automatic grounds for rejection.
 Questions regarding the bid documents will be received until 12:00
 - 3. Questions regarding the bid documents will be received until 12:00 p.m. on Thursday, October 12, 2023. (REVISED Date). All questions must be submitted in writing (via email, addressed to jerry@rgarchitects.net) to R G Architects. Neither R G Architects or the Owner will answer questions verbally.
 - 4. The last day for addenda to be issued, if required, shall be **Friday**, October 13, 2023. (REVISED Date).
- E. The project will require the contractors to utilize the State of Delaware Prevailing wage rates which are in the project manaual.
- F. Substitutions: If a specification lists one product manufacturer as well as listing "or equal", the contractor is not obligated to submit for substitution prior to bid for that item. However, the contractor will still be responsible to meet the requirements of that product during the review process as per the specifications. If the product substituted as an equal does not meet ALL of the requirements of the specifications, as determined by the Architect, the Contractor is obligated to provide the specified product at no additional cost to the project.
- G. Subcontractors List:
 - 1. The subcontractors list to be noted on the bid form in the project manual was reviewed and agreed upon. OMB/DFM has also added three more categories. Add the following:
 - 1. Metal Studs and Drywall
 - 2. Painting
 - 3. Ceilings
 - 4. Fire Protection
 - 5. Mechanical
 - 6. Plumbing
 - 7. Electrical
 - 2. The General Contractor may NOT list more than one subcontractor for a discipline on the subcontractor's list unless it is a second or third teer

contractor.

- 3. On the Subcontractors List, the General Contractor must list the subcontractor that is providing the labor for 100% of the work in that category and as is required by the laws of Title 29.
- H. Bidders were reminded to fill out the Bid Form completely & to not leave any areas to be filled out blank. The sub-contractor list is to be completed including a current Delaware Business License number. Bidders are to also list the Addenda issued. If five (5) Addenda was issued the Bid Form must note "1.2.3.4 & 5". Bid forms noting "1-5" will not be accepted. Bidders were also reminded to have the "Affidavit of Employees Drug Testing Program" form as part of their Bid.
- I. Drug Testing Policy: RGA reminded the new Drug Testing Policy in place by State of Delaware. Contractors are to reference the Project Manual for additional policy procedures and Drug Testing Report Forms.
- J. All are reminded that smoking is NOT permitted ANYWHERE on project property grounds. Contractors must leave the property to smoke during construction.
- K. The use of bathrooms on the premises will NOT be permitted during construction.
- L. The replacement of the electric transformer will be required. The contractor will need to reach out to the City of Dover to initiate that effort.
- M. Advantech will be hired separately by the State to perform security and access control work. The GC will be required to coordinate their schedules with Advantech.
- N. Fire Suppression and Fire Alarm is part of the GC's scope.
- O. The State will remove all loose furniture items prior to the start of construction.
- P. There are no restrictions on work hours.
- Q. Project Site walk-through
 - 1. RGA will email a link to Drop Box where the contractors can download all the pictures we have of the project. RGA will do this on 9/26/23
 - 2. The Contractors agreed that a future walk-thru was not required and will take place on 10/3 from 8:30 10:00am..
