1.0 GENERAL NOTES:

- 1.1 Bidders are hereby notified that this Addendum shall be and hereby becomes part of their Contract Documents, and shall be attached to the Project Manual for this project.
- 1.2 Bidders shall verify that their Sub-bidders are in full receipt of the information contained herein.
- 1.3 The pre-bid sign-in sheet, along with Addendum #1, is being sent as a courtesy to all pre-bid meeting attendees; however, all future addenda will only be issued to registered plan holders.
- 1.4 All addenda will be sent out to contractors via email. Contractors are encouraged to keep an eye on their email accounts during the bidding period for any and all updates.

PREBID MEETING:

- 2.1 Bid schedule is as follows:
 - 1. The bids are due until 2:00 p.m. on Thursday, JUNE 12th, 2025.
 - 2. Substitution requests will be received until 4:00 p.m. on JUNE 2, 2025.

processes, it is automatic grounds for rejection.

- 3. Questions regarding the bid documents will be received until 4:00 p.m. on JUNE 5th, 2025. All questions must be submitted in writing (via email, addressed to Neeka Grove, neeka@rgarchitects.net) at R G Architects. Neither R G Architects nor the Owner will answer questions verbally.
- 4. Last day for Addenda to be issued, if required, shall be, JUNE 9TH 2025.
- B. The project will require the contractors to utilize the current State of Delaware Prevailing wage rates included in the project manual.
- C. <u>Liquidated damages</u>: Liquidated damages are not in this contract. However, a written contract is, and all conditions of that contract will be enforced as spelled out in the contract documents.
- D. Substitutions Requests: All substitution requests shall be submitted per the project manual. Product comparison is required, and the contractor is responsible for submitting an equal substitution in comparison to the basis of design. All substitutions will be considered until the request deadline noted above.
- E. The project does not have any Alternates.
- F. The project has a General Allowance and is described in the project manual.
 - 1. Allowance \$10,000.00 and must initialed as acknowledged on the Bid Form.
- G. Subcontractors List to be noted on the Bid Form in the project manual was reviewed and agreed upon:
 - 1. TRADES LISTED:
 - a. ROOFING
 - b. ELECTRICAL
 - c. STEEL
 - 2. The General Contractor may NOT list more than one subcontractor for a discipline on the subcontractor's list unless it is a second or third tier contractor.
 - 3. On the Subcontractors List, the General Contractor must list the subcontractor that is providing the labor for 100% of the work in that category and as is required by the laws of Title 29.
- H. Note the Bid Form, in the project manual or updated via Addenda, is not to be altered in any way by the Bidder. Bid form is to be filled completely and any Addenda is to be noted as 1,2,3 and not 1-3 as per issued addenda.
- I. Non-Collusion Statement is included with the Bid Form and must be completed and notarized.
- J. Affidavit of Employee Drug Testing Program is included with the Bid Form and must
