A2 FRONT ELEVATION

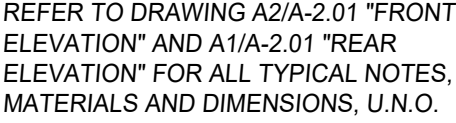
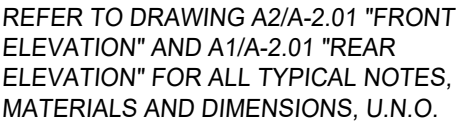

A1 REAR ELEVATION

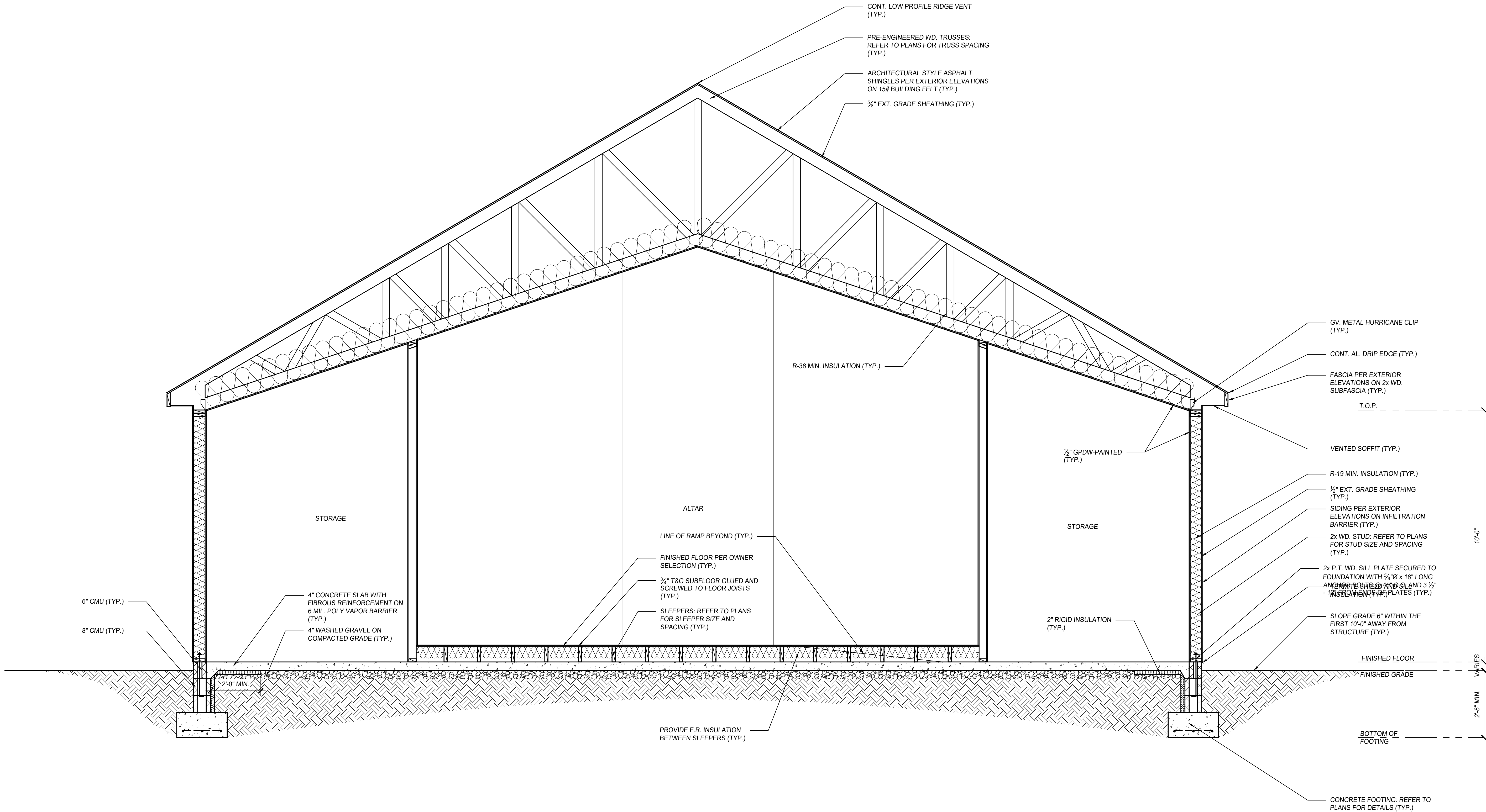

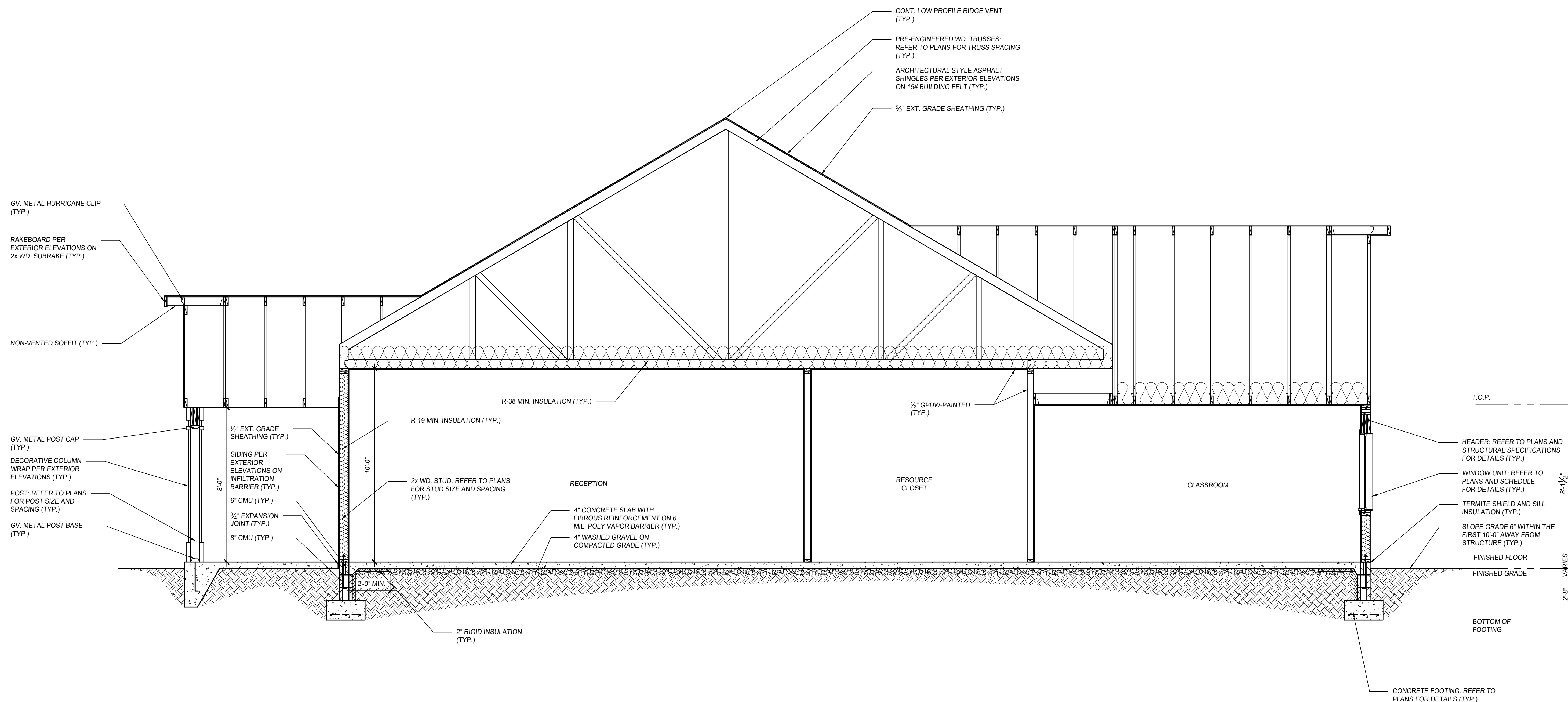

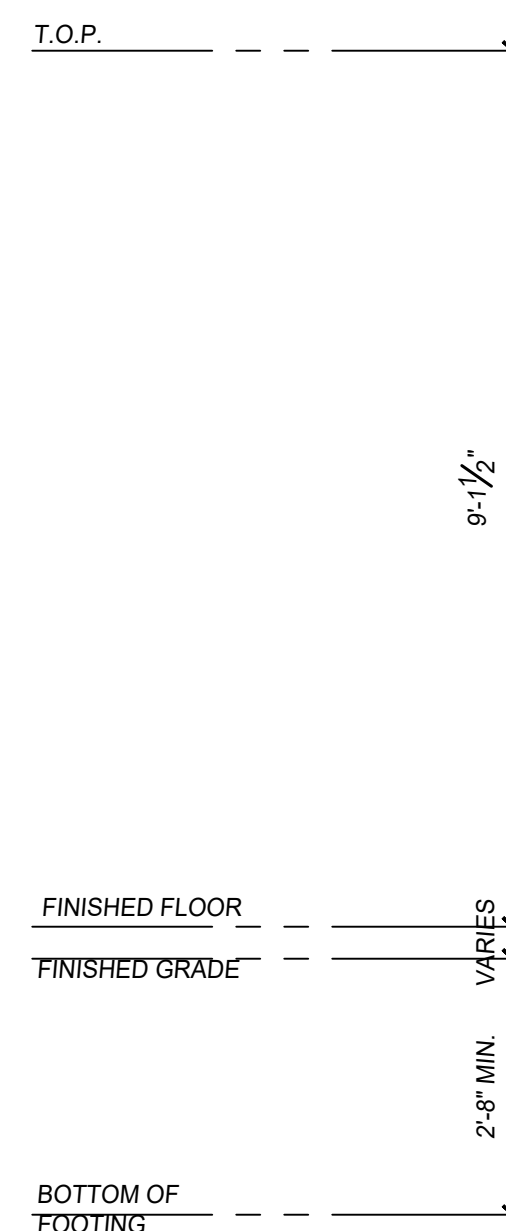
